The penalty for election falsification is imprisonment for up to two years and 12 months post-release supervision, or a fine not to exceed \$10,000.00 or both.

****For Nonpartisans ONLY:** If you wish to vote in this primary election for U.S. Senator and/or U.S. House of Representative, you may request a partisan ballot as stated in §32-912 (2) from one of the political parties by checking the appropriate box. (For the 2022 Primary, the Democratic, Libertarian and Legal Marijuana NOW parties opened their Primary Election to nonpartisans, so their ballot will contain federal, state and county offices. The Republican ballot will contain only senatorial and congressional races and candidates.)
