Marlin Kliewer appeared before the board to report on the operations of the Highway Dept.

Sharon Crouse, Public Health Solutions appeared before the board to present the Gage County Sheriff's dept with 2 Automatic External Defibrillators. The AED's were received through a grant applied for by Public Health Solutions.

Mark Meints and Millard Gustafson presented information on the need for a new generator for the jail. It was discussed that an emergency existed due to the necessity of having a generator in order to comply with jail standards and the fact the current generator is manual switch which creates potential back feed problems that could result in a dangerous situation for workers working on power lines down the line.

Setzer felt that the matter of the generator could wait 2 weeks and be placed on the next agenda.

Motion made by Bauman, seconded by Lytle to approve declaring the generator item as an emergency purchase under the 23-3109 (2) statute. Jurgens, Dorn, Bauman, Adams, Lytle, Byars, voting aye. Setzer voting nay. Motion carried 6-1.

Quotes were received by Homestead Electric in the amount of \$49,742.56 and Hartig Electric in the amount \$58,434.00. Three others were contacted to give a quote but declined.

Motion made by Bauman, seconded by Lytle to approve quote from Homestead Electric in the amount of \$49,742.56. Jurgens, Dorn, Bauman, Adams, Lytle, Byars, Setzer voting aye. Nay none. Motion carried 7-0.
