Shirley expressed disappointment that, according to what they had read, the 2 miles from Hwy 136 to Juniper Road on S. 66th Road were not being included. Ehme added that he thinks that overlaying should be considered.

Bauman led discussion on preliminary budget for FY 2012-2013. Mark Mainelli with Mainelli Wagner & Associates, Inc. spoke on behalf of the Road Department regarding their budget.

Committee reports were given by Dorn on Economic Development and Law Enforcement, Bauman on EMS contracts and Finance, Lytle on Emergency Management and Insurance, Setzer on Human Resources/Employee Relations and Jurgens on Road & Bridge.

Dorn acknowledged Jerry DeWitt's years of service to Gage County stating that DeWitt had done a lot of good for the county and commended his dedication and service. The board brought up the question of whether county offices would close for DeWitt's funeral on 8-9-12. For public awareness the board stated that it was up to the Elected Official/Dept. Head to decide whether or not they would close their individual office and they advise the public to check with the office they need to visit before coming in to see if they will remain open during that time.
