No public present for comments or request for future agenda items.

Committee reports were given by Byars and Dave Jones, Custodian, on Building & Grounds/Winter Lights, Dorn on Finance/Insurance, Setzer on Human Resources/Employee Relations, Lytle & Emer. Mgmt. Director Mark Meints on Law Enforcement/Emergency Management, and Jurgens on Road & Bridge.

The Board presented the Veteran Honor Award to Arnold Meints who was nominated by Arnold Buhr. Meints was inducted into the Army on April 18, 1942 and served until 1945. He was assigned to the 773rd Tank Destroyer Battalion, known for the taking out of the most tanks in any one battle which numbered 102 German tanks in The Battle of the Bulge. The final counts for their unit included 113 enemy tanks knocked out, 25 enemy guns knocked out, 105 pill boxes knocked out, 1,970 prisoners of war taken, and 8,219 destroyer rounds fired in direct fire. The Battalion served 254 days in combat, had 301 battle casualties and 55 non-battle casualties. Meints earned several honors including The Purple Heart during the Battle of The Bulge, the Good Conduct Medal, the Distinguished Unit Badge, the Presidential Unit Citation and the European-African-Middle Eastern Theater Medal. Meints' daughter and several other family members were present to celebrate the honor with him and she thanked the board, expressing how much the honor means to him.

Lisa Wiegand, Planning & Zoning Committee Chair, appeared before the board to give the committee's recommendation on Special Use Permit #2013-4 for construction of a 235 foot wireless communication tower located in the SE ¼ of Sec. 19, Barneston Township. She presented testimony from one individual and P & Z. The Committee recommends approval of the Special Use Permit #2013-4.

Motion made by Lytle, seconded by Dorn to open public hearing at 9:19 a.m. to hear support and/or opposition to Special Use Permit #2013-4 for construction of a wireless communications tower located in the SE ¼ of Sec. 19, Barneston Twp. Motion carried 7-0.
